National Action Plan - Preventing and Responding to Child Sexual Abuse Update July 2021

- The Plan was published in July 2019 and sets out thirty two actions against ten key objectives that the Welsh Government expects to be implemented https://gov.wales/preventing-and-responding-child-sexual-abuse-national-action-plan
- The reporting date for Period 2 in the Plan has been delayed from 31 January to 30 June 2021 as a result of the impact of the pandemic. The Deputy Minister has been asked to consider advice to delay the final reporting date for the Plan for Period 3 from 31 January to 30 June 2022.
- The actions for Period 1 are completed. Work to implement the actions set for the Welsh Government in Period 2 has progressed well; a traffic light system has been applied for ease. Three actions have been delayed as a result of the impact of the Covid-19 pandemic. We will work to progress delivery of these actions.
- The Safeguarding Children Boards have also reported on 30 June 2021 and a full report will be available in late July/early August.

Actions 2020-2021 – Period 2 (reporting 30 June 2021)

A4. Develop poster campaign on unsafe and unhealthy relationships for children and parent/carers Complete.

Commissioned by VAWDASV Division and published in July 2020 and available on the Hwb: Welsh English

A7. Develop resources to support parents/carers from Black, Asian and Ethnic Minority communities, parent/carers with disabled children and parent/carers with LGBT+ children and practitioners to understand CSA and how they can help to keep children safe.-Complete

In 2018/2019 we commissioned Stop it Now Cymru/The Lucy Faithfull Foundation to run a campaign to prevent child sexual abuse, identify child sexual abuse and provide information on to parent/carer and to practitioners on how to prevent, identify and respond to child sexual abuse. <u>https://www.stopitnow.org.uk/wales/what-we-all-need-to-know/</u>

This included information for parent/carers and for practitioners.

We commissioned <u>EYST</u>, <u>Stonewall Cymru</u>, and <u>Learning Disability Wales</u> to work with Stop it Now Cymru/The Lucy Faithfull Foundation to adapt and develop these resources to meet the needs of Black, Asian and Ethnic Minority, LGBT+ and learning disabled children and parent/carers. Information is available in English, Welsh and an additional 12 languages These resources were published in June 2021. <u>Publications and resources - Stop It Now</u> A10. Develop non-statutory practice guidance to support those working in education settings, in managing cases of peer-on-peer abuse within the education settings. The guidance will provide advice on ensuring that where there are concerns around HSB children can continue to receive an education in way, which is safe for them and for other learners- Complete

Guidance for education settings on peer sexual abuse, exploitation and harmful sexual behaviour -To be read in conjunction with the All Wales Practice Guide on Safeguarding Children where there are concerns about Harmful Sexual Behaviour and the Wales Safeguarding Procedures, was published in October 2020. This work was commissioned by Education Division from the NSPCC and Barnardo's Cymru.

A11. Develop information resources for practitioners and for parent/carers on CSE and HSB. Complete.

Barnardo's Cymru were commissioned to develop an online learning session on HSB, a guide for practitioners and information for parent/carers. These were published in June 2021.

Dr Sophie Hallett, Cardiff University was commissioned to develop online learning sessions and resources on safeguarding young people from CSE and related safeguarding issues such as CCE, trafficking and going missing. These were published on 1 July.

<u>Check Your Thinking – Resources to support safeguarding practice with young people, for use by all those working with and caring for young people.</u>

A14. Develop an exemplar corporate safeguarding policy in partnership with the Welsh Local Government Association (WLGA) for consideration by Safeguarding Board Partners. Delayed and not completed in Period 2.

This work was delayed because of the considerable pressure on the WLGA and on local authorities as a result of the pandemic response. Work will be prioritised to take this forward.

A19. Develop resources for children on what will happen if they tell an adult they are being abused- Complete.

The Welsh Government commissioned the NSPCC/Childline to develop information for children and young people to support disclosure and let them know what will happen if they tell an adult they have been/are being abused. These were published on the Childline site on 7 September 2020.

Stop it Now Cymru/The Lucy Faithfull Foundation were commissioned to develop this resource and it was launched in February 2021.

A27. Support the development of a national Service Specification for Sexual Assault Referral Centre services in Wales with the NHS Wales Health Collaborative taking into consideration a range of child-centred practice models.

The pandemic has impacted on the development of this work. However, a Sexual Assault Referral Services Programme of work has recently been taken back into the NHS Collaborative for oversight and leadership from Cardiff and Vale UHB. The new model will be staged in three phases: phase 1 focuses on the implementation of the SARC hubs for children and adults, establishment of the Operational Delivery Network and commissioning roles, and has been approved (including funding). Further work will be required on phase 2 (spokes) and phase 3 (forensic medical examiner provision).

Since decisions on the new model were agreed in 2019, new standards for forensic medical examination have been published and, whilst these require staged implementation between October 2020 and 2023, there is a major milestone to be met by January 2022 at the very latest for all SARC buildings to meet the requirements.

ISO accreditation standards are currently being worked towards and have to be met by October 2023 with next major milestone being a requirement for all SARC buildings to meet standards by January 2022. An interim solution is planned for the Cardiff and Aberystwyth SARCS as the new builds will not be completed within timescales.

Connections have been made Trauma Stress Wales (TSW) which aims is to use evidence based treatments to help reduce impact of traumatic events. Consideration will be given to the evaluation of the Child House Model and how this could inform our approach in Wales.

A30. Promote evidence and learning from the Welsh Government funded Gwella project – Complete (but will continue).

A successful Gwella Digital Conference 2020 was held on 15 October with over 600 delegates registering for the online event. The presentations and workshops from the day are available on demand once you register at the site. Resources are also available.
